Terms and Conditions for Bangalore Tour and Travel - Payments

By making a payment to Bangalore Tour and Travel, you agree to the following terms and conditions. These terms govern the payment process for all services offered by Bangalore Tour and Travel, including but not limited to flight bookings, hotel bookings, cab bookings, holiday packages, and other travel-related services.

1. Payment Methods

- 1 We accept various payment methods, including credit cards, debit cards, UPI, net banking, and other digital payment platforms. Specific payment options may vary depending on the services being booked.

- 2 We do not store any sensitive payment information, such as credit card details. All transactions are processed using industry-standard encryption protocols.
- 3 You are responsible for ensuring the confidentiality of your payment details and account information. Bangalore Tour and Travel will not be liable for any unauthorized transactions resulting from customer negligence.

4. Deposit and Advance Payments

- 1 For certain services such as holiday packages or long-term bookings, an advance deposit may be required to secure your reservation.
- 2 The amount of the deposit and the balance payment terms will be specified at the time of booking.
- 3 Failure to pay the deposit within the specified time frame may result in the booking being canceled, and any seats or reservations held will be released without notice.

5. Refunds and Cancellations

- 3 In cases of chargebacks initiated by the customer's bank or credit card provider, Bangalore Tour and Travel reserves the right to dispute the chargeback if the payment was authorized and valid.

7. Taxes and Fees

- 1 All prices quoted for services are inclusive of applicable taxes unless otherwise stated. Taxes may include Goods and Services Tax (GST), service charges, and any other applicable government levies.
- 2 Certain services may incur additional fees such as convenience charges, processing fees, or service charges, which will be communicated at the time of booking.

8. Partial Payments
